

## **NOTIFICATION ON PERSONAL DATA PROCESSING**

The data is collected and otherwise processed by the Serbian Chamber of Commerce, Resavska 13-15, Belgrade (hereinafter: the Chamber of Commerce), as a controller within the meaning of the Personal Data Protection Act ("Serbian Official Gazette" no. 87/18, hereinafter: the Act).

Personal data is collected for the purpose of communication and establishing business cooperation with regard to carrying out activities in the territory of the Republic of Serbia, as well as for the purpose of providing information on the business possibilities and promotion of services of the Serbian Chamber of Commerce.

The following data shall be collected: name and surname, telephone number, e-mail and CV.

The legal basis for the processing of your personal data is an informed consent within the meaning of Article 12, paragraph 1, item 1 and Article 15 of the Personal Data Protection Act ("Serbian Official Gazette" no. 87/18, hereinafter: the Act), which implies that you have been informed about all significant aspects of the processing of your personal data, as well as that you consent to such processing. You can revoke your consent at any time, which would entail the cessation of any further processing activity and the erasure of your data from the records within 10 work days after the revocation of your consent.

Your data will be stored until the revocation of your consent as stated in the previous paragraph, i.e. until the expiration of a two-year period from the date of data entry, after which the data will be anonymized or erased from the records.

When it comes to the processing of your personal data, we apply all necessary organizational, technical and personnel measures regarding personal data protection.

In terms of the processing of your personal data, you have all rights stipulated under the applicable Act, including the right to request access to personal data and information about processing (Article 26 of the Act); the right to request the rectification of incorrectly entered data and the completion of such data (Article 29 of the Act); the right to request the erasure of data (Article 30 of the Act); the right to restrict the processing (Article 31 of the Act); the right to data portability (Article 36 of the Act); the right to object (Article 37 of the Act); the right to lodge a complaint to the Commissioner for the Access to Information of Public Importance and Personal Data Protection – Bulevar kralja Aleksandra 15, 11120 Belgrade, telephone: 011/3408-900, e-mail: [office@poverenik.rs](mailto:office@poverenik.rs) (Article 82 of the Act); the right to remedy against the Commissioner's decision (Article 83 of the Act); the right to judicial remedy if you consider that your rights under this Act have been infringed (Article 84) and the right to receive damage compensation (Article 86 of the Act).

The person in charge of personal data protection will respond to your inquiry as soon as possible, depending on the complexity of the inquiry, but, in any case, within 30 days from the data subject's inquiry.
